

## **COMPANY POLICY**

In the panorama of industrial bodywork, la **SCATTOLINI S.p.A.** presents itself as the European leader in the production of equipment for commercial vehicles weighing up to 7.5 tons.

Production is oriented towards two types of product (fixed bodies and tipper bodies) supplied directly to car manufacturers or supplied to the dealer network in Italy and Europe.

The main raw material used is divided into: hot-dip galvanized steel sheets of various thicknesses and dimensions, extruded aluminum profiles of various geometries, wooden panels.
